The proceedings of the Ministry dated 17th February 2016 regarding the meeting in my office on 20th January 2016 may be referred. As per the decisions taken in the meeting, an explicit order may be issued clarifying following actions -

1. National Green Highways Mission (NGHM) under NHAI will be responsible for the implementation and monitoring of the Green Highways Projects of all agencies, including MoRTH, NHAI, & NHIDCL.
2. NGHM shall empanel, award & Monitor all plantation activities.
3. The NGHPs will be implemented as per the Vision & Guidelines, developed by the NGHM, through various agencies selected by the NGHM.
4. The Head of NGHM will be provided by NHAI with all required organizational structure and necessary administrative & financial powers.
5. NGHM shall verify and certify the bills raised by the appointed agencies for payment.
- ✓ 6. Disbursement of payments for the GHPs will be done by field units (PDs/ROs/Branch Offices of NHAI/MoRTH/NHIDCL).
- ✓ 7. Any supporting administration expenses disbursements NGHM shall be responsible. NHAI/MoRTH/NHIDCL will provide annual budget provision to NGHM for implementation of NGHPs.
8. NHAI/NHIDCL/MORTH shall issue clear & specific instructions to all PDs/ROs in this regard.
9. Besides the provisions of the order of MoRTH dated 16-08-16, the descoping of the plantation works from the Concessionaires Agreements may be done on case to case basis.
